HALL OF FAME POLICY

INDUSTRY PARTNER CATEGORY

There will be four (4) categories: Superior Performance, Veteran Superior Performance, Meritorious Service and Industry Partner. Eligibility: For Industry Partner, the nominee should have worked closely with the Morris County USBC WBA for a minimum of ten (10) years.

Award is presented to an “**Industry Partner**”, to acknowledge Proprietors, Managers and Sports Writers. These individuals working together with the Morris County USBC Women's Bowling Association to deliver quality products and services; establish technical standards, provide arenas for local competition, and promote awareness and a positive image for the sport of bowling.

1. A qualified candidate should also meet the following criteria:
 - a. Made valuable and significant contributions to our Association
 - b. Provided enthusiastic support to the Association and the bowlers
 - c. Embraced the same ideals as our Volunteers and Leaders
2. The Morris County USBC WBA Board of Directors and Hall of Fame Committee Members will elect members to the Morris County USBC WBA Hall of Fame by secret ballot.
3. Voting: Each voting member shall be entitled to vote for not more than three (3) candidates in Superior Performance, two (2) candidates in Veteran Superior Performance, three (3) candidates in Meritorious Service and one (1) candidate for Industry Partner. Candidates receiving at least 55% of the returned ballot votes in each category will be inducted into the Morris County USBC WBA Hall of Fame.
4. The committee shall return credentials to the unsuccessful candidates and the person who submitted them so they can update and resubmit for future consideration. The current chairperson shall provide the Association Manager with copies of all credentials for the county office immediately following the selection of the inductees. Therefore, the Association Manager must keep any names submitted on file until the next Hall of Fame.
